Skagit County Fairgrounds Arena Rules:

- > A leader **must** be present for the whole ride night
- > Only **enrolled** members and leaders are allowed to be horseback
- Members and leaders **must** wear helmets, boots, long pants, and t-shirts (no bare shoulders) when mounted
- > Boots are required for any person handling horses
- > Riding in the arenas only; no riding in the parking area or on grass areas
- > Parents **must** wear close-toed shoes
- > Dogs **must** remain in the parking area and on a leash at all times
- All children **must** be in eyesight of the club; please use good parental judgment!
- NO smoking/alcohol anywhere on the fairgrounds

Fair MEMBER Participation Requirements

- Submit an up-to-date Record Book to Horse Leaders on or before the following date*:
 - May 21st @ Skagit County Fairgrounds, 5:30pm-6:45pm
- 2. Participate in the county Public Presentation contest.
 - March 12th, 14th or 16th
 - Online Registration, check with your leader for details
- 3. Participate in one Horse Bowl contest or Hippology contest.
 - Horse Bowl:
 - January 17th, Location TBA
 - > Juniors @ 5:30pm
 - ➤ Intermediates @ 6:15pm
 - > Seniors @ 7:00pm
 - Saturday, February 10th during Equine Extravaganza, location TBA Make-ups for Horse Bowl can be completed by attending a practice for the State Horse Bowl team in February. Contact Sharrie Nelson for more details.
 - Hippology
 - Saturday, March 9th @ Silver Quarters Arena, after judging

 - ➤ Know Your Government
 - You may choose to attend an outside educational event or clinic. In order for your event to count towards your fair requirement:
 - > Event must be horse-related
 - > Event must be a minimum of 1 hour long
 - Event must be pre-approved by Horse Leaders. Submit your request through your club leader at least 14 days prior to the event to be discussed and voted on at the next Horse Leaders monthly meeting.
 - Member must write a half-page summary on what the event was, who spoke, subject matter covered, what was learned, and how new information will be applicable to their project/chosen career path. Summary must be emailed to schorseleaders@gmail.com within 1 week of the event.
- 6. Submit signed Guardian/Member Project Expectations Agreement (page 6 of this packet) to County 4-H office on or before the 1st Monday in May (with your Blue Slip) before 4:00pm.
- 7. Submit one Educational Poster to be displayed at the Skagit County Fair
 - July 27th by 6PM & 28th by 2PM, at Skagit Fairgrounds, During Clover Classic

FINAL MAKE-UPS – May 29th, 5:30pm at the Skagit County Fairgrounds: final chance to make up Public Presentation, Record Book, Horsebowl and/or Hippology and Judging requirements in order to show at the County Fair as a Complete Member.

Members must make the May 21st submission deadline for Record Books. If book is found to be incomplete then the member has until the Final Make-Up date to complete the book. Books not turned in by the first deadline do not qualify for the extension and member will be considered "Incomplete".

Fair HORSE Participation Requirements (Main and Back-up Horses)

- Complete an up-to-date Project Record and time invested record (1 per horse) in your record book.
- Blue Slip with color photo submitted to County 4-H Office on or before the 1st Monday in May before 4:00pm (1 per horse).
- Flu/Rhino vaccinations between February 6th and July 23rd shots must be administered by a veterinarian and you must have signed documentation from your veterinarian. Horses without this record will not be admitted onto the Fairgrounds.

What is an "Incomplete" Member?

An Incomplete Member will show at the County Fair as a Substitute Horse, and will be required to help at a County event that is approved by the Horse Leaders committee.

- Did not submit an up-to-date Record Book, or did not submit a complete Record Book by the Final Make-Up date; OR
- Did not participate in one Public Presentation, Horse Bowl/Hippology, and Horse Judging contest, AND did not attend the Final Make-Up date; OR Did not attend an Educational Event; OR Did not submit an Educational Poster; OR Did not submit a signed Guardian/Member Project Expectations Agreement

What is a "Substitute" Horse?

A Substitute Horse cannot win Grand or Reserve in any class at the County Fair, and does not qualify for any State Team. This includes horses substituted due to illness or injury after the 1st Monday of May deadline.

- Incomplete Member
- Does not have an up-to-date Individual Horse Record and time invested record in member's Record Book.
- A Blue Slip was not submitted by the 1st Monday of May. All horses must have a Blue Slip submitted to correspond with their vaccination record.

Bringing in a Back Up Horse after the Start of Fair:

Members may bring in a qualified back up horse (see HORSE Participation Requirements) if the member's main horse must go home after the start of Fair due to illness, catastrophic injury, or vet recommendation. The member is responsible for arranging and paying for an additional vet check to admit the incoming horse. The new horse/member combo will not be eligible for high point awards or State Fair qualification however they may be eligible for Grand and Reserve rosettes.

Per Skagit County Fair rules and regulations, any one removing a horse from the Fairgrounds before dismissal or without permission from the Superintendent will not receive their fair premiums.

Novice Performance Division 1 Walk Trot: all first-year members are eligible:

1st year horse project members will be eligible for all Danish ribbons, Grand Champion, Reserve Grand Champion and placing ribbons. There will be an award for High Point and Reserve High Point. Riders will not be eligible for state fair.

Walk Trot Performance Division2 W/T: for members that have been to fair previously and are recommended by their leaders to be in a walk trot setting. Riders in this group will be eligible for all Danish ribbons, Grand Champion, Reserve Grand Champion and placing ribbons. There will be an award for High Point and Reserve High Point. Riders will not be eligible for state fair.

Novice Games Division: all first-year members are eligible: Members with green horses or who are first year gamers may also compete in the novice games division with leader recommendation.

All members will be eligible for all Danish ribbons, Grand Champion, Reserve Grand Champion and placing ribbons. There will be an award for High Point and Reserve High Point. Riders will not be eligible for state fair.

State Fair Double Qualifying Opportunity

Members will have an opportunity to double-qualify for State Fair at the July Clover Classic. To qualify:

- Horse must qualify for the County Fair, see Fair HORSE Participation Requirements above.
- You must enter all qualifying events for that discipline at the Clover Classic OR Skagit County Fair.
- You must compete in different disciplines at the Clover Classic and the Skagit County Fair.
- You must attend and compete at the Skagit County Fair.
 - The following State Fair classes may or may not be offered at the county level. Members may still qualify for State in those classes. If interested, contact the Fair Superintendent:
 - > Dressage > Reining (seniors only) > Small horse classes (more info to come)

At several points during the 4-H year members and parents/guardians are required to read and sign rules and Codes of Conduct. It is expected that each parent/guardian and member fully understand and abide by all rules and regulations during 4-H activities. Any disciplinary action will be at the discretion of, and taken by, the Horse Superintendent and/or the County 4-H Coordinator.
